The third annual meeting of the Broome Family Foundation Board of Directors was the best yet. Board members celebrated the accomplishments of 2012 and committed to supporting and moving BFF forward in 2013.

The BFF team inspired the Board with reports about how BFF teams equipped dozens of youn people and families to live lives of real value and significance through its Aspire Supplemental Education, the Next Level, and Hope4Families programs.

The Aspire Supplemental Education team reported that families, impressed by Hope4Families services, also sought the services of Aspire Supplemental Education. As a result, Aspire

provided instruction to special education students throughout Southern California and helped them improve their academic success.

The Next Level team reported that about its partnership with the **Holman Community** Development Corporation to provide free PSAT/SAT preparation classes to students in the community. The first event was a great success. At least 30 students attended the class and 75% of the students showed improvement on post class assessments.

The Hope4Families team reported that it had its best year. It helped more special needs students and their families last year than in the two prior years combined.

Aspire is Bridging the Achievement Gap

Aspire Supplemental Education is bridging the achievement gap for special needs students. Andrew is a case in point. Andrew is an intelligent young man. He attended a charter school that is considered one of the best in Los Angeles. He was performing well below grade level, however, in all core subject areas. Andrew's problem has been that for years he has missed, on average, 25% of the school year.

Andrew has hemophilia that is so severe that he was recently a "Make a Wish" awardee. It is not uncommon for relatively minor incidents to force him to stay at home to recuperate or even send him to the hospital. Aspire instructor Kenter Ludlow spent hours with Andrew teaching him reading and math and helping Andrew increase his performance. Andrew is now performing close to grade level. Aspire instructors are honoring BFF's mission to equip young people with special needs for lives of real value and significance.

Special Education Parent Workshop

Hope4Familes 2nd Annual Workshop takes place on February 23, 2013

Thanks to the generosity of the California Endowment, Hope4Families will hold its second annual Special Education Parent Workshop at the Tom Bradley Family Source Center in Los Angeles on February 23, 2012.

The workshop is intended to help parents understand the purpose of special education and recognize when their children may require special education services. It will also equip parents with skills

to work with schools and, when necessary, advocate for their children.

The workshop will feature presentations by Hope4Families Managing Attorney Margaret J. McNair who will use an interactive approach to provide an overview of the Individuals with Disabilities Act (IDEA), a description of special needs assessments and an explanation of the different ways schools can provide Free and Appropriate Education

(FAPE). Courtney
McNair, a California
Certificated Special
Education Teacher and
BFF Board Member will
provide the parents with
the special education
teacher perspective.
Finally, Researcher
Diana Tisnado, PhD will
provide her perspective
as the mother of a
special needs student.

What Is An Independent Educational Evaluation?

What is an Independent Educational Evaluation?

An Independent
Educational Evaluation
(IEE) is an evaluation of
a child that is performed
by a professional who is
independent of the child's
school district or public
charter school. The
person who conducts the
IEE is not an employee or
associate of the district.

When should I request an IEE for my child?

An IEE is often helpful if you need more information, different information or a second opinion about your child's disability or special needs.

An IEE is the best choice if any or all of the

following circumstances apply to you and your child:

- Your child's current assessment(s) were incomplete and did not provide enough information about your child's needs.
- •Your child's current assessment(s) were inaccurate, and you believe the results are false.
- •Your child's current assessment(s) were inadequate, and you feel your child was not assessed in every area of suspected need.
- •The District is denying your child Special Education eligibility or services because of a poorly done assessment or lack of proper

assessment.

How do I request an IEE?

You have a right to an Independent Educational Evaluation at public expense. The District is required by law to pay for an IEE if they have failed to assess your child properly.

Request an IEE by writing a letter stating your disagreement with the district's current assessments. You may state why you disagree, but this is not necessary. You can submit this letter to a school administrator or the head of the IEP team at your child's school. It is recommended that you personally deliver or mail this letter. A phone call or e-mail is **not** sufficient to request an IEE.

Equipping Students to Take the Next Step

The achievement gap devastates young people and families of color. It causes poverty, lower living standards, and increased criminality. An achievement gap refers to the disparity on a number of educational measures.

An article in the Journal of Blacks in Higher Education attributed the achievement gap on the SAT to, among other factors, disparity in income between the families of color and white families. Moreover, public schools in communities of color are "ill equipped to provide the same quality of secondary education that is offered in predominately white suburban school districts." After a yearlong

study, a council comprised of education, business and community leaders convened by then Superintendent of Schools Jack O'Connell issued a report about closing the achievement gap that came to a similar conclusion. The committee pointed to lack of access to "accelerated interventions." In other words, young people of color do not have the same access to resources like quality supplemental education services as their white counterparts.

To resolve this discrepancy, BFF's Next Level program partnered with the Holman Community Development Corporation to present a quality SAT preparation program. The program was oversubscribed. Attendance was supposed to be limited to 25 students,

Attendance was supposed to be limited to 25 students but 30 students attended the program and were accommodated.

Examinations taken by the students before and after the program revealed that the students not only performed better academically, but just as important, they increased their familiarity with the SAT exam.

The program honored BFF's mission to equip young people by facilitating improved SAT performance and increasing their exposure to this vital exam.
